Accommodations, Club Rental & Unlimited Tee Times from \$142 Per Person

Horseshoe Bay, TX – February 9, 2009 – Horseshoe Bay Resort is inviting golfers to focus on their game and not their gear with the *Just Bring Your Swing* package. Now through April 30, 2009, the offer includes club rental so drive-in golfers can avoid taking up trunk space and those flying in can bypass dreaded baggage fees. Unlimited tee times on any of the resort's three Robert Trent Jones, Sr. courses, and shuttle service to and from the greens are included, starting at just \$142 per person, based on two golfers per room.* If both travelers don't share a love of the greens, rates are available for duos with only one golfer per room. A two-night minimum stay is required, and accommodations range from hotel rooms to one-, two-, and three-bedroom Paseo villas or lakefront condominiums at The Waters.**

Fairway fanatics can hit the links on the resort's award-winning championship Robert Trent Jones, Sr. golf courses:

Slick Rock: Built in 1971 and spanning approximately 170 acres, this course provides more than 33,700 feet of golf frontage property. With bentgrass greens, multiple tees on every hole, more than 71 sand traps and 12 water hazards, Slick Rock embodies the Robert Trent Jones, Sr. philosophy of "hard par, easy bogey."

Ram Rock: The course was recently named one of the "Best Resort Courses of 2009" by *Golfweek* magazine, and a "Favorite Course Over \$100" by the *PGA Professionals' Guide to Travel*. Constructed in 1981, narrow fairways and rolling Crenshaw bentgrass greens are surrounded by 62 deep bunkers, 10 water hazards and natural dry creeks on six holes. With its dramatic elevation changes, Ram Rock, nicknamed the "Challenger," offers enough length and difficulty to challenge scratch players in any group.

Apple Rock: Horseshoe Bay Resort's third championship Robert Trent Jones, Sr. course was completed in 1986 and is widely known as one of the most scenic courses in the state. The spectacular greens span 147 acres of the rolling Texas Hill Country along the shores of Lake LBJ.

Travelers receive temporary membership at Horseshoe Bay Resort granting access to resort facilities, including an 18-hole par 72 Bermuda grass putting course, seven dining facilities, a spa and fitness facility, 12 adult tennis courts, three USTA-sponsored kids' tennis courts, and a jet center with a 6,000-foot runway.
